Subject: 40 CFR Part 257, Subpart D, Section 257.91(f) Groundwater Monitoring System Certification Wisconsin Public Service Corporation - Weston Generating Station Units 3 & 4 Bottom Ash Basins, Rothschild, WI

Dear Tom:

According to Title 40 Code of Federal Regulations (40 CFR) Part 257, Subpart D, Section 257.91(f); the owner or operator of a coal combustion residual (CCR) management unit must obtain a certification from a qualified professional engineer stating that the groundwater monitoring system at the CCR management unit has been designed and constructed to meet the requirements of Section 257.91. Further, Section 257.91 requires that the system monitor the uppermost aquifer and include a minimum of one updgradient and three downgradient monitoring wells, and that if the uppermost aquifer monitoring system includes the minimum number of wells the basis supporting use of the minimum must be documented.

A groundwater monitoring system that meets and exceeds the minimum requirements of Section 257.91 is designed for the Wisconsin Public Service Corporation (WPSC) Weston Units 3 & 4 Bottom Ash Basins, including the following monitoring wells:

Upgradient: OW-45, OW-46

Downgradient: OW-47R, OW-48, OW-49, OW-50

Provided herein, as required by Section 257.91(f), is certification from a qualified professional engineer and professional geologist that the groundwater monitoring system at the WPSC Weston Units 3 & 4 Bottom Ash Basins meets the requirements of Section 257.91.
